Storage and Security of Information

We receive and store information on our website or in other ways from time to time. We will use all reasonable means to protect the confidentiality of their Personal Data while in our possession or control. We will not knowingly share any of their Personal Data with any third party other than our service providers who assist us in providing the information and/or services we are providing to clients.
